

Terms and Conditions, which will apply to Neways Distributors:

1) Upon acceptance of this Application by Neways Europe BVBA ("Neways"), you will be authorized to represent yourself as an Independent Distributor of Neways products. You will then be entitled to purchase Neways products for your own personal consumption as well as for your business and market the products and present the Neways opportunity. You are not being granted an exclusive distributorship or territorial exclusivity.

2) By signing this Application, you represent that you have carefully read and agree to be bound by and comply with these Terms and Conditions, the Neways Policies and Procedures, and the Neways Compensation Plan, all of which together form the entire distribution agreement between you and Neways (the "Distributor Agreement"). Neways may amend this Agreement from time to time upon notice to you; please refer to the Neways Policies and Procedures for more specific details. To the extent of any conflict or inconsistency between the documents comprising the Distributor Agreement; the Policies and Procedures shall supersede and prevail over all others, and these Terms and Conditions supersede and prevail over all except the Policies and Procedures. You also agree to comply with all of the rules and codes of conduct of the applicable Direct Selling Associations.

3) The term of this Distributor Agreement is one year. An annual renewal fee of €10 will be charged starting 12 months after becoming a Distributor. If you fail to pay your annual renewal fee, or if your Distributor Agreement is terminated for any other reason, you will lose all rights as a Distributor. In the event of termination, you shall lose as of the effective termination date any rights, including but not limited to property rights, to your former downline organization and to any bonuses or commissions derived through the sales or other activity of your former

downline organisation.

4) You must be in compliance with the terms of this Distributor Agreement in order to be eligible to receive bonuses and commissions from Neways. You understand that if you fail to comply with the terms of the Distributor Agreement, Neways may, at its reasonable discretion, impose upon you disciplinary action as set forth in the Policies and Procedures.

5) This Distributor Agreement is personal to you and may not be assigned or otherwise transferred to anyone without the prior written consent of Neways (which may be granted or declined at Neways' sole discretion). Neways may assign this Distributor Agreement to any of its affiliates without your consent.

6) As a Distributor and a self-employed businessperson, you are not an employee or agent of Neways. You are not authorized to make representations or incur any liabilities on behalf of Neways and must not purport to do so. You are responsible for your own business decisions and all expenses incurred in running your business.

7) You may use Neways' tradenames, trademarks and copyrights only for the purpose of your Neways business and in accordance with the terms of this Agreement.

8) You agree that the names, addresses, and contact details of Neways Distributors, and any other information provided to you for working with your downline, or for any other reason, are Neways' confidential proprietary information, and will only be used by you for the purpose of your Neways business.

9) You have the right to terminate your Distributor Agreement at any time for any reason.

10) Unless the law of the jurisdiction where you reside requires otherwise, all disputes and claims relating to the Distributor Agreement, your Neways business and Neways products and services shall be governed by Belgian law, and shall be submitted to a competent court in Brussels.

11) If you wish to bring an action against Neways for any act or omission relating to or arising from this Distributor Agreement, such action must be brought within one year from the date of the alleged conduct giving rise to the cause of action. Failure to do so shall bar all claims against Neways for such act or omission. You waive all claims that any other statute of limitation applies.

12) You authorize Neways to use your name, photograph, personal story, and/or likeness in advertising or promotional materials and waive all claims for remuneration for such use.

13) If any provision of this Distributor Agreement is held by a court to be illegal, unenforceable, or invalid in whole or in part, the remainder of that provision and all other parts of the Distributor Agreement will continue to be binding and have effect.

14) Any notice you wish to send to Neways should be sent to its address shown on the application form. Any notices Neways wishes to send you will be sent to your address provided on the application form or to any other address you have notified Neways in writing should be used in its place. Changes by Neways to the Distributor Agreement may be notified by any reasonable means, including newsletters and other Neways publications circulated generally to Distributors.

If you are not satisfied with the product for any reason, it may be returned, at Neways' cost, for a 100% refund (including shipping costs) if written notice of cancellation is sent to Neways within 14 days from the time of delivery. Timely dispatch of the mailing before expiration of the 14 days will suffice. Any clause whereby the consumer would waive this right is null and void. If goods received are faulty or non-conforming, statutory rights apply. Please report faulty orders to Neways customer service as soon as possible so that the mistake can be remedied.
